

Hamilton Co. Health Dept. Set to Begin Offering COVID-19 Vaccinations to Residents Age 65 or Older, Certain School Teachers, and School Staff on February 22

The Hamilton County Health Department announced its age-based vaccinations will soon include Hamilton County residents age 65 or older. **Beginning Monday, February 22**, any Hamilton County resident age 65 or older will be eligible to schedule COVID-19 vaccine appointments. This move represents a transition from the previous age bracket limiting COVID-19 vaccinations to individuals age 70 or older. There are no medical conditions required for age-based eligibility. This means that individuals age 65 or older will only need to show proof of residency at his or her appointment. Proof of residency can be shown with documentation verifying the individual's home address.

The Health Department also announced expansion to Phase 1b. This expansion means childcare, pre-school, and K-12 teachers will be eligible for COVID-19 vaccinations on February 22 as well. School staff and school bus drivers are included in Phase 1b. First responders not already included in Phases 1a1 will be a part of Phase 1b. Phase-based eligibility requires proof of employment at the vaccination site. This expansion in Hamilton County coincides with the update to the Tennessee Department of Health's Vaccination Plan taking place across the State of Tennessee.

The Hamilton County Health Department will not allow members of the expanded groups access to the appointments prior to February 22. Eligible individuals are encouraged to continue monitoring for announcements of additional appointment opportunities.

Who: Hamilton County residents age 65 or older and Phase 1b (childcare, pre-school, kindergarten through 12th grade teachers, school staff, school bus drivers, and first responders not already included in Phase 1a1).

Where: The exact location is determined at time of appointment.
